WILSON PARKING AUSTRALIA "Melbourne United Wilson Parking Super Seats" TERMS AND CONDITIONS

1. INTRODUCTION

- 1.1 The following terms and conditions apply for the Wilson Parking Australia "Melbourne United Wilson Parking Super Seats" (the "Competition") and by submitting an entry into this Competition, entrants warrant that they have read, understand and agree to be bound by them.

2. PROMOTER

The promoter is Wilson Parking Australia 1992 Pty Ltd (ABN 67 052 475 911) (the "Promoter"), Floor 7, 7 Macquarie Place SYDNEY NSW 2000.

3. DURATION

Entries will be taken from 12.00pm (AEST) Thursday 24 October 2024 until 12.00pm (AEDT) on Thursday 6 February, 2025 inclusive ("Registration Period"). Entries will reset after each prize draw as outlined in Clause 6.1.

4. ELIGIBILITY

- 5.3 Entries not containing the weekly codeword will not be eligible to enter.
- 5.4 Should an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the Promoter. A request to access or modify any information provided in an entry should be directed to the Promoter.
